2. Membership

Full. Full membership permits attendance at all Vintage Arms Association (VAA) ranges, subject to local restrictions. A Full member has voting rights in the Association, and will receive the Association periodical, *The Primer*. Applications for membership must be proposed by a current Full VAA member of at least two years standing, and countersigned by an Association Committee member. Applications must be accompanied by a recent passport-style photograph of the applicant, and one-twelfth of the annual fee for each remaining month or part-month from application to the membership year end, March 31st. Life membership is available for a single payment of ten times the Full (including Senior and Jersey) fee.

Senior. Full membership is open at a reduced rate to those of UK pensionable age.

Jersey. Full membership is open at a reduced rate to those resident in the States of Jersey CI.

Family membership is open to the spouse or partner, and to any son or daughter under the age of twenty-one, of a Full member. A Family member may attend Association range meetings only while under the direct supervision of their respective Full member, or as directed by the Range Conducting Officer (RCO) on the day. A Family member has no voting rights in the Association, and does not receive *The Primer*.

Junior membership is open to all persons under the age of twenty-one as proposed by a Full VAA member. A Junior member may attend Association range meetings only while under the direct supervision of the proposing member, or as directed by the RCO on the day. A Junior member has no voting rights in the Association, and does not receive *The Primer*.

Corresponding membership is open to all. A Corresponding member has voting rights, and will receive the Association periodical. A Corresponding member may not attend Association ranges other than as a Guest of the Association.

Probation

A probationary period will normally be offered to applicants, during which they will be supervised at all times while in possession of firearms and/or ammunition. The extent of supervision required will be determined by the Range Conducting Officer. On successful completion of this initial period, probationers may apply to the Committee for full membership. The probationary period may be waived for those applicants who are suitably qualified and experienced.

Submitting the Application

Applications may be submitted to a VAA committee member or emailed to the Vintage Arms at members@vintagearms.org.uk. Emailed applications should be in jpg format (pages 1 and 2) and include a separate passport-style jpg colour photograph. Payment may be made via BACS bank transfer or at any branch of Barclays bank using the payment details as shown above..

3. Conditions of Membership

- 3.1 Membership is conditional upon timely annual renewal, and a satisfactory attendance record.
Membership may be terminated for cause at the sole discretion of the Committee.
- 3.2 Members will notify the committee of any change to their recorded personal details or FAC conditions within 30 days.
- 3.3 Membership ends March 31st on which date all membership rights and range access cease. A period of grace until April 30th may be allowed at the discretion of the Committee to renew without forfeiture of membership. This period does not extend membership in any way. A lapsed member failing to renew by April 30th is deemed to have resigned from the Association. Former members wishing to re-join after April 30th should submit a new application for approval by the Committee.
- 3.4 Members will observe all local range regulations concerning permitted ammunition type, muzzle energy and the ballistic performance of commercial and hand-loaded ammunition. The Range Conducting Officer's decision is final in all matters relating to range safety and security. Disputes must be directed to the Committee, and not to the RCO or to any third party.
- 3.5 Members will carry a valid membership card and, where appropriate, a Shooter Certification Card, at all times while on the range. Those who fail to comply may be refused entry.
- 3.6 No photographic or video recording equipment may be used at any Association meeting without prior permission from a Committee member. No person may be photographed or recorded in any format without their express permission while on Association business. Photographic, audio or video material relating to any Association activity may not be discussed on any social media site, uploaded to the internet or sent to any media organisation without the prior written consent of the Committee Chairman.
- 3.7 Members shooting on Ministry of Defence (Landmarc) ranges must hold a National Rifle Association Shooter Certification Card (SCC) issued by a Home Office Approved club. Members requiring an SCC from the VAA should contact a range secretary. All cards issued by the VAA must be returned on cessation of membership, or if so requested by the Committee.
- 3.8 Guests are permitted only if they are members of a Home Office Approved club, or hold a personal Firearm Certificate, or are attending an official Association Guest Day as published on the Association website and in the periodical.

4. Data Privacy

The Vintage Arms Association (VAA) is both controller and processor of its members data, and may use the information provided on the application form and in any other communication in all matters as stated under the VAA Data Privacy Notice. The VAA reserve the right to change the Data Privacy Notice at any time, and will notify members of any substantial updates. Members are advised to read this document, and any other privacy notice that may be provided when collecting or processing personal data in order to be aware of how this information will be used. 5. Declaration
